
The undersigned is directed to say that it is proposed to dispose of one Ambassador car bearing Registration Number DL 2CM-1733 make Model, 2000.

2. Accordingly, sealed quotations are invited for the disposal of said vehicle on the terms and conditions mentioned below. In case you are interested in purchasing the above mentioned vehicle, you may submit your quotation in the enclosed Performa. The quotations addressed to the undersigned in a sealed cover should reach this Department latest by 3.30.PM on 3rd November, 2009. The quotations received in time will be opened at 4.00 PM on the same day (3rd November, 2009) in Room No.15, Ground Floor, Udyog Bhawan, New Delhi. The bidders or their representative (only one) may be present, if they so desire, at the time of opening of quotation. The quotations should be dropped in the Tender Box kept in Room No.15, Udyog Bhawan, New Delhi. The cover should be prominently sub-scribed with the words "**QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE**". The vehicle will be available for inspection between **3.00 P.M. to 5.00 PM on 29th And 30th October, 2009.**

3. The sale will be governed by the following conditions:

- i) The bidder is required to pay Earnest Money of Rs. 10,000/- payable by means of Demand Draft drawn in favor of Drawing and Disbursing Officer,, Ministry of Heavy Industry, New Delhi.
- ii) Quotations received without demand draft towards Earnest Money will not be considered and shall not be accepted.
- iii) The successful bidder will be required to deposit the bid amount by means of cash/ demand draft drawn in favour of Drawing and Disbursing Officer,, Ministry of Heavy Industry, New Delhi, within two working days of the acceptance of the bid.

- iv) The Earnest Money of the successful bidder will be released only after the deposit of sale proceeds. Earnest Money will be forfeited if he fails to honour the bid.
- v) The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status viz. Ration Card/Voter identity Card/Passport in case of individual and Registration Certificate in case of firms etc.
- vi) The sold vehicle will be removed by the successful bidder within two days of depositing the money at their own expenses.
