Annexure-II

The firm need to submit the following documents along with the application:-

1. Copy of IEM / IL in respect of item(s) of manufacture.
2. The plant layout clearly indicating the machines already installed and new machines to be installed and progress (expenditure) made towards procurement of land, building and plant & machinery separately, as on the date of application.
3. Justification and end use of each machine / equipment to be imported supported by technical literature along with calculation sheet in respect of capacity of each machine and also attach relevant proforma invoices or purchase orders. The second hand machineries will be considered as per the import policy applicable from time to time.
4. The details of the list of indigenous machines to be installed, indicating the quantity and value for the project.
5. Copies of clearances received from State Government/ agencies in respect of land, water, power, pollution, etc.
6. Whether the initial setting up of unit or substantial expansion is being carried out in single phase or in multiple phases - the details thereof for different phases may be indicated.
7. The production figures of the item(s) of manufacture for the last three years in value and quantity being manufactured at the existing plant/unit (applicable only in the case of substantial expansion and the manufacture of new article at the existing location)
8. The installed capacity of the plant for the item(s) of manufacture (applicable only in the case of substantial expansion)
