Statement referred to in reply to Part (a) to (e) of Lok Sabha Starred Question No. 136 for answer on 2.12.2014 regarding SETTING UP OF HEAVY INDUSTRIES BY DR. C. GOPALAKRISHNAN; SMT. SANTOSH AHLAWAT

Since Industry is a State subject, hence no centralized data is maintained in this Department for heavy industries set up in various parts of the country. The details of Central Public Sector Enterprises (CPSEs) functioning in different parts of the country, including CPSEs under administrative control of this Department is placed at Annexure-A. A separate list of CPSEs under the administrative control of this Department has also been provided at Annexure-B.

There is no proposal in this Department for setting up of heavy industry /PSU in any area of the country under the "Make in India" programme. The CPSEs under the Department of Heavy Industry (DHI) set up their units based on commercial considerations. Further, States encourage the setting up of industries as per their priorities and investment climate and details of such nature are only expected to be available with them.
