

The performance highlights of the Department of Heavy Industry for the month of July, 2011:-.

I Bharat Heavy Electricals Ltd. (BHEL)

Order booking:

The total order receipts in the current financial year **up-to July 2011** has reached a level of ₹ **4021 Crs** which include orders worth ₹ **1426 Crs.** booked during July 2011. Major orders received during the month include:
