Appointment on Compassionate Grounds in CCI

3250. SHRI JANARDAN SINGH SIGRIWAL:

Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:

- (a) the details of appointment on compassionate grounds in the Cement Corporation of India (CCI) during each of the last three years and the current year;
- (b) whether a large number of applications for appointment on compassionate grounds are pending for a long time with the CCI;
- (c) if so, the details thereof along with the criteria fixed for these appointments; and
- (d) the steps taken/proposed to be taken by the Government to address the issue and the time by which the pending appointments are likely to be made?

Cement Corporation of India Limited (CCI) is a sick BIFR referred company. It has got 3 operating units and 7 non-operating units. As per the revival scheme approved by the BIFR/Govt., 6 of its non-operating units have been closed and 3 operating units are under modernisation. In view of the manpower requirement for 3 operating units/corporate office, the sanctioned strength is to be determined on the basis of finalisation of the manpower study undertaken by the Administrative Staff College of India, Hyderabad. Filling in the vacancies on compassionate grounds depends upon finalised sanctioned strength.
