

MONTHLY SUMMARY FOR THE MONTH OF JULY, 2015

The report of Department of Heavy Industry for the month of July, 2015 is as follows:

1. Andrew Yule Company Limited, a CPSE under DHI, which had been under reference to BIFR, since 2003, was discharged from its purview on 8th July, 2015 as its net worth has turned positive.
2. Braithwaite Burn Jessop Construction Company Limited (BBJ) and Bharat Bhari Udyog Nigam Limited (BBUNL), two CPSUs under DHI have merged into one entity w.e.f. 10th July, 2015. The merged entity will now be known as BBJ.
3. Chairman & Managing Director, Bharat Heavy Electricals Limited (BHEL) participated in the round-table interaction with the CEOs of India and Kazakhstan, co chaired by Hon'ble PM and Mr. Karim Massimov, Prime Minister of Kazakhstan at Astana, Kazakhstan. BHEL signed three Strategic MoUs with Kazakh companies for setting up power projects in Kazakhstan and other countries and arranging financing for modernization of hydro and thermal power projects.
4. A project for upgradation & modernization of "Turkmen India Industrial Training Centre"(TIITC), Ashgabat, Turkmenistan agreed earlier by the Governments of India and Turkmenistan and entrusted to HMT (International) Limited, has been successfully completed. The completion of the project was announced in the joint statement by Hon'ble PM and the President of Turkmenistan on 11th July, 2015. The project was officially handed over to Ministry of Education, Government of Turkmenistan/Turkmen State Architecture and Construction Institute, Ashgabat, Turkmenistan by the Embassy of India on 12th July, 2015.
5. The Institute of Cost Accountants of India has conferred the prestigious National Award for Excellence in Cost Management, First Prize under the category of Public- Manufacturing: Organisation (Medium) on Cement Corporation of India. The award was presented by Col. Rajya Vardhan Rathore (Retd.), AVSM, Minister of State for Information & Broadcasting on Wednesday, 15th July, 2015.
6. Under the Scheme for Enhancement of Competitiveness in the Indian Capital Goods Sector, a number of Road Shows have been planned in collaboration with FICCI in major cities. After organizing the first Road Show in Ahmadabad on 29th May, 2015, another Road Show was held in Mumbai on 6th July, 2015 which was presided over by Shri Anant G. Geete M(HI&PE) and Shri Diwakar Narayan Raote, Hon'ble Minister of Transport, Government of Maharashtra delivered the Keynote Address in the workshop.
7. It has been decided to develop an online application for submission, screening, approval and monitoring module for proposals under Scheme for Enhancement of Competitiveness in the Capital Goods Sector. This endeavor has been made a part of the Scheme on Good Governance and Best Practices by Department of Electronics and Information Technology (DeitY).
8. A new Pedestrian Safety Test Facility set up at ARAI Chakan Centre, has been completed and was inaugurated by the Secretary (DHI) on 13th July, 2015. The world class Pedestrian Safety Test facility is useful for Pedestrian as well as Occupant Safety Impact simulation testing. The facility mainly comprises of the Universal Launcher which has various inter-changeable impact modules to simulate different impact test conditions as per national as well as international standards.
9. On the request of the Expenditure Management Commission, The Secretary (DHI) had briefed the Chairman of the Commission Dr. Bimal Jalan and other Members on 20th July, 2015 on the Department's Road Map for Closure of CPSEs dependent on Salary Support from the Government, and other related issues.
