



MONTHLY SUMMARY OF SIGNIFICANT ACTIVITIES FOR DECEMBER, 2016

This has reference to your DO letter No. 502/1/2/2014-CA-V dated August 5, 2014 regarding important issues/developments. The following significant activities have taken place during the month of December, 2016 in the Department of Heavy Industry (DHI).

1. A meeting between the delegation from Czech Republic headed by H.E. Lubomir Zaoralek, Minister of Foreign Affairs of the Czech Republic and Hon'ble Minister of State (HI&PE) was held on 19<sup>th</sup> December, 2016 to discuss in brief about areas of possible economic cooperation between India and Czech Republic with special emphasis on Heavy Industries Sector.
2. To promulgate the use of Official Language in the Department and to encourage Officers/officials of the Department to increase the progressive use of Hindi in their Official work, Hindi Fortnight was organized by the Department during 01-15 September, 2016. Various competitions were organized amongst officials of the Department in which Officers up to the level of Directors participated with enthusiasm. The winners of these competitions were felicitated in a ceremony by Shri Anant G. Geete, Hon'ble Minister (HI&PE) on 8<sup>th</sup> December, 2016. Hon'ble Minister in his speech, encouraged the award winning participants and other officers present to do their official work in Hindi.
3. In pursuance of the Orders of Department of Official Language, Hindi Advisory Committee's second meeting for the year 2016 of Ministry of Heavy Industries and Public Enterprises which includes two Departments i.e. Department of Heavy Industry and Department of Public Enterprises was successfully organised on 29.12.2016 in Hyderabad. During this meeting, Sh. Shankarbhai N. Vegad, MP (RS) and Sh. Maheish Girri, MP (LS) and other Non-official members imparted cogent and persuasive propositions and suggestions for the progressive use of Hindi and lauded the work done by the department in the august presence of Chairman of the Committee and Hon'ble Minister.
4. Secretary, HI inaugurated the event WIN INDIA on "Integrated Industry" at Mumbai in collaboration with HMF India and FICCI from 3<sup>rd</sup> — 5<sup>th</sup> December. A CEO roundtable on "Automation and job creation in Capital Goods Sectors" was held during the event, under the chairmanship of Member NITI Aayog Dr. V.K. Saraswat. The meeting was also attended by Principle Scientific Advisor (PSA) to Prime Minister; Secretary Science & Technology, Scientific Secretary Office of PSA and Joint Secretaries of Commerce, DIPP and DDP.

13. Hon'ble Prime Minister, presented a cheque of the highest amount among all the organizations of Rs.1.79 Crore to BHEL, at the "Kaushal Mahotsava", as a mark of appreciation for engaging large number of apprentices under the National Apprenticeship Promotion Scheme, representing the contribution to the 'Skill India' initiative.
14. For the 26th consecutive year, BHEL received the Star Performer EEPC INDIA National Award for Export Excellence for the year 2014-15 from Hon'ble Union Minister of Railways, on 13th December, 2016.
15. BHEL has been conferred SKOCH Order of merit for Smart Technology-Technologies of Growth and Blue Economy- Health activities in CSR on 19th December, 2016.
16. BHEL received Governance Now Best PSE (Maharatna) for R & D and Technology Adoption from Hon'ble Union Minister of Consumer Affairs, Food and Public Distribution on 23rd December, 2016 in presence of Hon'ble MoS (HI &PE). BHEL was also conferred CBIP Award for Best Power Equipment Manufacturing Organization on 29th December, 2016.
17. BHEL has achieved a provisional turnover of Rs. 19274 Cr. up to December, 2016 as against Rs.16246 Cr. for the corresponding period last year, an increase of 19%.
