## DEPARTMENT OF HEAVY INDUSTRY

### MONTHLY SUMMARY OF SIGNIFICANT ACTIVITIES FOR FEBRUARY, 2016

#### A. Automotive Sector:

1. **'Make in India week' organised at Mumbai:-** The inaugural session on 'Making India a Global Manufacturing Hub for Auto and Auto Components' was addressed by Hon'ble Minister (HI&PE) on 17<sup>th</sup> February, 2016 during 'Make in India week' program at Mumbai.
2. **7th JASIC Forum:-** Director (Auto), HI visited Tokyo on 12/2/2016 to attend the 7th India-Japan Automobile Standards Internationalization Centre (JASIC) Forum.
3. **Meeting of the Indo-German Joint Working Group:-** 9<sup>th</sup> Meeting of the Indo-German Joint Working Group on Automobiles was held on 5<sup>th</sup> February, 2016 in Gr. Noida, UP.
4. **'Auto Expo 2016':-** 'Auto Expo 2016' was inaugurated by Hon'ble Minister of HI&PE on 4<sup>th</sup> February 2016 at India Expo Mart, Greater Noida.
5. **ACMA organized Automotive Summit:-** Hon'ble Minister (HI&PE) had addressed 1<sup>st</sup> New Delhi Automotive Summit on 5<sup>th</sup> February, 2016 organized by ACMA in New Delhi.

#### B. Heavy Engineering & Machine Tools Sector:

1. **Announcement of 'National Capital Goods Policy 2016':-** The 'National Capital Goods Policy 2016' was announced on 15<sup>th</sup> February, 2016 during the 'Make in India Week' held in Mumbai. The policy has been formulated under 'Make in India' initiative in extensive consultation with the Industry, Industry Associations, concerned Ministries/ Departments and user industry at both regional and national level.
2. **Seminar on 'Capital Goods and Engineering Realizing the Make in India vision':-** Department of Heavy Industry organized three seminars in the 'Make in India Week' at Mumbai. On 15<sup>th</sup> February 2016 a seminar was organized on 'Capital Goods and Engineering: Realizing the Make in India vision'. The Seminar was inaugurated by Hon'ble Minister (HI&PE).
3. **Seminar on 'Construction Equipment & Technology':-** A seminar on 'Construction Equipment & Technology' was organized on 17<sup>th</sup> February. Secretary(HI) delivered the Key Note address in the seminar.
4. **Meeting on National Institute of Manufacturing Technology:-** A meeting

was held on 22.2.2016 on skill development and developing a multi-locational "National Institute of Manufacturing Technology" (NIMT) on hub & spoke model for training, education, and research in manufacturing technologies by leveraging the infrastructure and facilities of PSUs under DHI. Representatives of MSDE and Capital Goods Skill Council attended the meeting, where it was decided to conceptualize a National Institute of Manufacturing Technology (NIMT) on a hub and spoke model.

5. **Global Innovation and Technology Alliance (GITA):-** The Apex Committee, in its meeting dated 28.01.2016, under the Chairmanship of Secretary(HI) approved the proposal for engaging Global Innovation and Technology Alliance (GITA) for marketing, promotion and implementation of the "Technology Acquisition Fund Programme (TAFP)" component of the Scheme on "Enhancement of Competitiveness in the Indian Capital Goods Sector". The Request For Proposal (RFP) under TAFP was also issued by GITA, on February 26, 2016.

**C. Heavy Engineering Industries/CPSES under DHI:**

1. **BHEL booked Orders worth Rs.10,570 Crore:-** BHEL has booked Orders worth Rs.10,570 Cr. during the month of February 2016. With this the total order booking in the current financial year up to February 2016 stands at Rs. 42,045 Cr. as against Rs. 23,416 Cr. for the corresponding period last year.
2. **BHEL participated in 'Make in India' week:-** BHEL participated in 'Make in India' week held in Mumbai from 13-18 February, 2016, and put up a pavilion in the exhibition. I had visited BHEL's pavilion. CMD, BHEL made a presentation in plenary session on '*India as a World-Class Capital Goods Manufacturing Nation.*'
3. **BHEL participated in ELECRAMA-2016 at Bengaluru:-** BHEL put up a pavilion in the ELECRAMA-2016 (13-17 February 2016) at Bengaluru highlighting the new clean green business solutions covering solar PV plants, e-Mobility, and water management, etc. Hon'ble Minister (HI&PE) and other senior govt. officials visited BHEL's pavilion.
4. **Inauguration of ICAT, Manesar:-** On 23<sup>rd</sup> Feb, 2016 Hon'ble Minister (HI&PE) had inaugurated ICAT, Manesar with four test facilities i) Climatic Vehicle Test Cell (CVTC), ii) Computer aided design & computer aided engineering (CADCAE), iii) Engine test cell (ETC) and iv) Infotronics lab under NATRIP.
5. **Standing Finance Committee (SFC) recommends gauge conversion for Cachhar Mills seeking fund support:-** A meeting of Standing Finance Committee (SFC) was held on 26.2.2016 for evaluation of proposal of UPC seeking fund support of Rs. 1922.76 lakh from Ministry of Development of North Eastern Region for conversion of MG to BG from Panchgram Station to inside

Cachhar Paper Mill (CPM) premises (a unit of HPC). SFC agreed to the proposal. Proposal has been sent to DoNER for their approval and allocation/release of fund.

6. **Appointment of Non-official Directors for various CPSEs:-** This Department forwarded a list of 24 Panels for appointment of Non-official Directors for various CPSEs under this Department to DPE for obtaining approval of Search Committee, a Meeting for which was held on 5.2.2016. Out of the above, 18 names were recommended by the Search Committee for appointment as Non-official Directors.
7. **CCEA approves delinking of REIL from ILK:-** The Cabinet Committee on Economic Affairs, in its meeting on 3.2.2016, approved delinking of Rajasthan Electronics & Instruments Limited (REIL), Jaipur from Instrumentation Limited (IL) by transferring the entire shareholding of 51% held by IL in REIL to Government of India in order to facilitate REIL, a profit making company, in expanding its activities significantly, improving credit rating of the company & increased growth and business opportunities.
