With reference to D.O. letter No.502/1/2/2014-CA-V dated August 5, 2014 of Cabinet Secretary, the following significant activities in the Department of Heavy Industry (DHI) for the month of January, 2020 are highlighted:

1. Letters of award are being issued to selected entities for establishment of 2636 charging stations in 62 cities of 24 States/UTs, as sanctioned by the Government under FAME India (Faster Adoption and Manufacturing of Electric Vehicles in India) Scheme Phase II. Letters of award were issued to those selected entities which submitted MoUs with different cities/urban local bodies/other entities for implementing charging stations at identified locations.
2. I attended the Annual Meeting of the World Economic Forum, held at Davos, Switzerland from 20-24 January 2020. The visit was extremely useful as it gave me the opportunity to learn about the state of play in Industry 4.0 amongst the manufacturing leaders of the world. I used this opportunity to invite investment to India during my one- to- one meetings with CEOs and global business leaders from the Automobile and the Capital Goods sectors. I attended some thought provoking sessions during the WEF.
3. An awareness workshop on Smart Manufacturing and Industry 4.0, "Are You Ready for the Digital Transformation " was organized by the Department of Heavy Industry along with the C4i4 Lab on 24th January 2020 at the K K Wagh Institute of Engineering Education & Research, Panchavati, Nashik. Industry participants and experts attended this workshop. This was the 22<sup>nd</sup> Industry 4.0 workshop conducted during the year 2019-20 by the Department.
4. As per directions of the Inter Ministerial Group (IMG), the re-estimation of mining reserves was done by CCI through the Mineral Exploration Corporation Limited (MECL) a GoI undertaking. The MECL report indicates a five fold increase in the limestone reserves. This material increase in resources was considered by the Evaluation Sub Committee on 08.01.2020. The ESC, in the interest of transparency, recommended inviting a fresh EoI wherein the existing shortlisted bidders would continue to be eligible without payment of any additional fee or documentation. The IMG co-chaired by Secretary DIPAM and me in its meeting on 28.01.2019 has agreed to this suggestion. The revised EoI/PIM are under preparation.
5. BHEL signed a Memorandum of Understanding (MoU) with Energy Efficiency Services Limited (EESL) on 29<sup>th</sup> January 2020, for co-operation in exploring opportunities, developing, establishing, operating and maintaining public EV charging infrastructure across various highways and cities pan India.

6. A joint presentation of CSIR and BHEL was made to Hon'ble Minister Jal Shakti and Secretary (Jal Shakti) on 29<sup>th</sup> January 2020, during which a number of areas were identified where CSIR & BHEL would work jointly for meeting national requirements in the areas of water management and promoting "Make In India".
7. Central Railway's first air-conditioned ACEMU rake, equipped with BHEL electrics, was inaugurated for commercial operation between Thane-Panvel on 30<sup>th</sup> January 2020.
8. Hon'ble Minister of State for Tribal Development, Gujarat launched Solar Dual Pump Water Supply Scheme at Saronda village of Umargam taluka of Valsad district on 17<sup>th</sup> January 2020- the scheme is based on a unique concept wherein a hand pump is integrated with solar submersible pump, and is being executed by BHEL across five districts (Surat, Valsad, Dahod, Chhotaudepur and Vadodara) of Gujarat.
9. BHEL participated in 'ELECARAMA 2020' organized by IEEMA from 18 to 22 January 2020 at India Expo Centre, Greater Noida. The exhibition stall of BHEL was inaugurated by Hon'ble Union Minister of State (IC) of New & Renewable Energy, Power.
10. Eight BHEL Townships have been declared as 'Single Use Plastic free' township.
11. The Department-related Parliamentary Standing committee (DRPSC) on Industry held discussions regarding CSR with senior representatives/ officials of the select organizations, including BHEL/DHI on 7<sup>th</sup> January 2020.
12. The Parliamentary Committee on Subordinate Legislation, Rajya Sabha held discussions on various rules pertaining to waste management with senior representatives/ officials of the state government of Telangana, CPCB, Ministries / Departments of the Govt. of India along with select organizations, including BHEL, on 23<sup>rd</sup> January 2020 at Hyderabad.
13. On 21st January, 2020, Hon'ble Parliamentary Committee on *Rajbhasha* conducted an inspection of the working of *Rajbhasha* in the Power sector of Western region, BHEL at Nagpur.
14. In view of the Cabinet Secretariat's direction dated 12-01-2017 vide D.O letter No.1/50/1/2017-Cab, the status of ACC directions/ orders as per the prescribed format is given as under:
